Privacy Policy

Introduction

Registration

Members are asked to provide certain personal information when they sign up for our Services including name, address, telephone number, and/or billing information (such as a credit card number). The personal information collected from Members during the registration process is used to manage each Member's account (such as for billing purposes and invoice). This information is not shared with third parties, unless when booking third party's services on your behalf. However, in instances where ASDPS Randotrek and a partner jointly manage the Services, Randotrek may provide the partner certain personal information always with your permission and subscription. In this instance, personal information may not be used by the partner for any other purpose. Randotrek must also share personal information Members provide during registration (such as name, address, country) to AICS (Associazione Italiana Cultura Sport) for membership card processing.

Randotrek Partners and Sponsors

Discount services are offered to Members in conjunction with non-affiliated partners. To provide Members some of these products and services, the partner may need to collect and maintain personal information. In these instances, you will be notified before any such data is collected or transferred and may decide not to use that particular service or feature.

Responses to Email Inquiries

When Visitors or Members send email inquiries to ASDPS Randotrek, the return email address is used to answer the email inquiry we receive. Randotrek does not use the return email address for any other purpose and does not share the return email address with any third party.
